6. Property Units Update

Residential – there is currently only one vacant residential property;

• 1 Market Road – as previously reported, this property is currently being used as a welfare facility during the Town Hall works period.

Commercial - there are currently no vacant commercial properties.

7. General including ongoing activities in the Admin Office The Office continues to support the organisation across the range of Civic, administrative, financial and corporate activities.

Pay Award 2023/2024 - as previously advised, the Employer Side had made a full and final

offer to the staff side in connection with the 2023-24 pay settlement. This amounted to an award of £1,925 (pro rata as appropriate) to those posts on SCPs 2-43, and an increase of 3.88% to those posts on SCPs 44 and above. This offer was rejected by Unison. Unison members had until 4th July to vote on whether or not they were willing to take strike action. The result was that whilst sufficient numbers responded to the survey, insufficient Unison members said they would be willing to strike, therefore the possibility of strike action by that Union fell away. Negotiations with other Unions are now taking place. Further updates will be provided, when available.

8. Website & Accessibility update

Booking forms/schedules of charges for various Council activities are assessed on an ongoing basis and will be updated, where necessary, to ensure compliance with the regulations. Overall site compliance is reviewed annually. We have been advised that the current host platform service for our website is being upgraded in January, 2025. Therefore, depending upon transfer cost (which is being explored) potential options include either transfer or procurement exercise. Further updates will be submitted as they become available.

9. Legal Services

In the early part of 2024 arrangements will need to be made to either re-tender or renegotiate legal services for the Council, in view of the timeframe for current arrangements. A review of present arrangements, including with our provider, will be undertaken in the New Year to help inform next steps.

10. Lettable Properties and Energy Performance

Energy Performance Certificates (EPC's) and Display Performance Certificates (DPC's) are in certain circumstances a requirement for the letting of properties. However, the position lacks clarity regarding certain classes of Listed premises and further information is being sought prior to upcoming changes in minimum thresholds for eligible premises.

 Civic Event – the Council is invited to endorse participation in arrangements to commemorate the 80th anniversary of the D Day landings at the request of the Pageant Master (extract reproduced below):

'As you are aware, we are organising D-Day 80 – 6th June 2024, throughout the United Kingdom, Channel Islands, Isle of Man, UK Overseas Territories and at the site of the British Normandy Memorial, overlooking Gold Beach in Normandy, France, one of the five Beaches landed on 80 years ago on 6th June next year. The event is in celebration and commemoration of this important occasion and will enable communities and individuals to pay their 'tribute' to those that gave so much during this campaign to help ensure the freedom we all enjoy today, with the flames from the Beacons representing the 'light of peace' that emerged from the dreadful darkness of war all those years ago.

We feel sure you will agree with me/us when we say that individuals and communities of all sizes were deeply affected in many and various ways during WWII. So, with this in mind, we would like to encourage your Town or Parish Council to take part in D-Day 80 on 6th June next year, as we would like to achieve the lighting of at least 80 Beacons per County, within England and Wales, as part of this 80th Anniversary event. We would be extremely grateful if you would be kind enough to discuss your possible involvement with your Council members, at your earliest convenience please, with the view to ensuring we achieve the lighting of this number if Beacons in your County at 9.15pm on 6th June 2024.'
