TLU are a utility contractor working on behalf of Airband. We have civil engineering work to carry out at the above location which unfortunately will require a full road closure in order to safely excavate. This is due to the width of the street, meaning once our site is set up there will be no space for even single lane traffic.

I am advised by Devon County Council that in order to submit a road closure application we should first consult parties in the public and business domain potentially affected by our closure, including the Parish Council.

Therefore, this notification is to advise you that we intend to submit a road closure application for 27th of September until 29th of September 2023.


I attach a map showing the section of the road what we will be closing, access will be maintained at all the times for the residents.

Dear Sir/Madam.

TLU are a civil engineering contractor working on behalf of Airband. We undertake underground civils work to allow for the installation of new high speed fibre optic networks. We have a piece of civil engineering work that we have been asked to carry out at the above location.

Because of the nature of the work and the narrow width of the road, it has been necessary to apply for a TEMPORARY TRAFFIC RESTRICTION ORDER (TTRO), and following the statutory three-month notice period, we now have permission from **Devon Highways** to begin work on **27/09/2023** for a duration of **3** days.

During the course of the work, we can allow pedestrian access and of course access to any emergency vehicles. Residents' vehicles will also be able to access properties, but it should be noted where we are working at any given time, so that residents enter from the end of the closure not affected by the works. However, normal passing traffic will not be able to move through the site and will use an approved diversion which will be clearly indicated via standard signage.

We will make every effort to keep disruption to a minimum during this period and we thank you in advance for your patience and assistance.
