Noted That arising from consideration of Minute No. 421 a Councillor made a statement disagreeing with the content of the Minute and alleged breaches of statutory and/or other provisions. Reference was further made to the content of the document which had given rise to the Minute by way of explanation and, in particular, the perceived impact of same and views of the Member concerned.

In the ensuing discussion reference was made variously to:-

a) The origins of the matter and extent to which it was/was not appropriate to be included within the normal course of business of the Council at that time;

- b) Related details including reference to aspects of Council projects and practices;
- c) Whether the Council may have been brought into disrepute;
- d) The accuracy or otherwise of the documents under discussion;
- e) The importance of Councillors working collaboratively together with the opportunities and obligations placed upon them in the conduct of their duties.

A motion was received and duly seconded that

"In light of the Local Government Act 1986, this Council wishes to disassociate itself from the matters included in item 421 – Councillor Conduct and apologises to the Councillor in question for any breach of the Act".

Upon receipt of a request the voting was recorded by way of roll call.

Abstained - Councillors Mrs A Johnson, Mrs J Metcalf.

The motion was defeated by nine votes to three with two abstentions.

RESOLVED THAT subject to any amendments listed above the recommendations included in the foregoing reports of Committee Meetings be approved and the reports be received.

a) Calendar of Meetings 2015/16

The Council received and considered an indicative Calendar of Meetings for the 2015/16 Civic Year which would be finalised, in due course, by the new Council at the Annual Meeting.
