Summary of Representations

Comment	Devon County Council Response
First Respondent: Resident of Drake Villas, Tavistock	
There are times when resident has no alternative but to pull up and load or unload heavy items. Would like to know if these proposals will prevent this.	Residents will be able to load/unload in the limited waiting. They can also still utilise the double yellow lines remaining on the west side of the road.
Would like to know if there is a possibility of making the bay a priority for residents.	This would require the introduction of a residents parking scheme which is outside the remit of this Traffic Regulation Order (TRO).
Current situation the spaces are occupied for long periods of time by non-residents making it difficult to load or unload shopping.	Noted.
Second Respondent: Tavistock Town Council	
Objects to the proposals to move the limited waiting bay to the opposite side of the road	Noted.
Concerns there would be problems for large vehicles travelling north and turning into Callington Road (A390). Believes it will cause congestion and delays.	The width of the road remains unchanged and the centre line will be adjusted accordingly to maintain the running lanes for traffic travelling between the roundabouts. Therefore, it is not considered moving the parking to the opposite side of the road will affect congestion and delays.
