Devon County Council propose to make this under the Road Traffic Regulation Act 1984 to

EXTEND the 30mph speed limit by virtue of street lighting (**RESTRICTED ROAD**) from a point 164 metres south-west of the centre line of its junction with Abbotsfield Crescent south westwards for a distance of 137 metres

INTRODUCE a 30mph speed limit on Callington Road (A390), from a point 301 metres southwest of the centre line of its junction with Abbotsfield Crescent south westwards for a distance of 70 metres

Statement of Reasons

The proposed extension to the 30mph speed limit is considered necessary to reduce the speed of traffic adjacent to the new residential development scheme off Callington Road and on the approach to the new roundabout on the A390. This is to improve road safety for all road users in the area. The extension will include a length of restricted road (30mph by virtue of new street lighting) and 70 metres of 30mph speed limit beyond the extent of the streetlighting.

Specifically, this will avoid danger to persons or other traffic using the road or any other road or for preventing the likelihood of any such danger arising and to preserve or improve the amenities of the area through which the road runs.

Devon County Council make the following order in exercise of powers under sections 82, 83, 84 of the Road Traffic Regulation Act 1984 ("Act") & of all other enabling powers

- This order comes into force and may be cited as "Devon County Council (Callington Road (A390), Tavistock) (Restricted Road & 30mph Speed Limit) Order "
- 2 The length of road specified in schedule 1 is a restricted road for the purpose of section 81 of the Act
- 3 No person shall drive any motor vehicle at a speed exceeding 30mph on the length of road specified in schedule 2
- 4 No speed limit imposed by this order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011
