Devon County Council (Drake Villas, Tavistock) (Waiting & Loading Restrictions) Amendment Order

Devon County Council propose to make this under the Road Traffic Regulation Act 1984:

NO WAITING AT ANY TIME, NO LOADING AT ANY TIME and LIMITED WAITING (Mon-Sat 8am-6pm 45 Minutes No Return Within 90 Minutes) on specified lengths of Drake Villas, Tavistock.

Where appropriate there will be the usual exemptions including those in relation to the picking up & setting down of passengers, loading/unloading of goods & disabled persons vehicles.

Statement of Reasons

The proposed restrictions is the relocation of the existing limited waiting bay on the east side of Drake Villas to the west side. This proposal is required as part of the improved, widened, northern approach to Drakes roundabout.

Specifically, the proposed restrictions will facilitate the passage on the road or any other road of any class of traffic (including pedestrians) and to preserve/improve the amenities of the area through which the roads run.
