## **274. DECLARATIONS OF INTEREST**

There were no Declarations of Interest.

## 275. CONFIRMATION OF MINUTES

RESOLVED THAT the Minutes of the Meeting of the Properties Committee held on Tuesday  $12^{\text{th}}$  January, 2016 be confirmed as a correct record and signed by the Chairman.

Noted That arising from consideration of the above, Officers undertook to incorporate timeline information within action logs.

## 276. ITEMS REQUIRING A DECISION

The Committee considered the following matter requiring a decision:-

# a) Tavistock Community Sensory Garden

The Committee considered a request from the Rotary Club of Tavistock that the Town Council accept the role of Lead Council, and support an



application for, a Tavistock Community Sensory Garden to the Town and Parish (TAP) Fund (Appendix 1).

In the discussion arising from consideration of the above particular reference was made to the past involvement of the Council and partners in the development of the scheme, funding arrangements, examples of sensory gardens elsewhere and proposals for future maintenance (to be provided by partners on a volunteer basis).

RECOMMENDED THAT the Council accept the designation of Lead Body and support the application made by the Tavistock Rotary Club to the TAP fund for a Tavistock Community Sensory Garden.

Noted That in response to questions reference was made to:-

- Progress with the letting of the Butchers Hall roofing contract (expected shortly) – the preferred tender being within the approved budget;
- ii. Anticipated delivery of Wi-Fi in the Pannier Market scheduled for March 2016;
- iii. Guildhall refurbishment architectural services. Tenders had been received and evaluated and, subject to due diligence, the Council would shortly be in a position to let the contract for Lead Architect (the tender sum falling within the approved budget);
- iv. Butchers Hall future usage confirmation that under the terms of the application made to Heritage Lottery Fund the future use of the Butchers Hall to which the Council had committed would be market related usage;
- v. Dog Issues reference to an item on the agenda for the Finance and General Purposes Committee, the issue of dog fouling and the merits and drawbacks associated with the suggestion.

Noted That reference was made to completion of survey works regarding prospective remedial action in connection with the Cemetery Lodge together with the extent to which measures could/could not be implemented to mitigate the effect of flooding from the River Tavy onto Dolvin Road. Reference was also made to the pothole register.
